A Flash of Lightning

Understanding Property Tax

hat do you know about property taxes? Are you a head of household? A veteran? Do you know the deadline for appealing an assessed value? Are you a sufferer of "lightning tax"? A recent article in the Albuquerque Journal reminded us that an understanding of property taxes may be an elusive subject for some of our clientele. So, we have put together a list of information that should come ning, is making herself available for our cliin handy.

How are properties assessed?

Real estate is valued for tax purposes by county assessors or appraisers. This official valuation process is called assessment. A property's value is generally based on the sales prices of comparable properties. The property is to be assessed at its fair market value as of January 1 of the current tax year. The tax ratio in New Mexico is 33 1/3%. So as an example, a home with a fair market value of \$140,000 will have a total assessed value of \$45,662. Property valuation increases are capped at three percent over the previous year's value. The reason for these caps is to permit reassessment on a regular basis but limit "sudden and huge" increases to the property owner. This cap does not apply in the cases of new improvements to the property or in the change of ownership.

What then is Property Lightning Tax?

Tax lightning is when someone who buy a new home experiences a dramatic increase in property taxes because the property they purchased is no longer covered under the state's 3% annual assessment increase. This means new homeowners could have property tax bills much higher than their neighbors. Recently, at least two state district judges have ruled that "tax lightning" is unconstitutional because it unfairly created a class of people who are taxed more because they bought their home, i.e., there was a change of ownership of the home. (Note: Those who purchased a home in 2008 are about to see their first tax bill and may see the "lightning tax" effect. How can I lower my property taxes?

New Mexico allows for two exemptions head-of-household deduction is \$2,000 and an eligible qualified veteran's deduction is now \$4,000. Those eligible for one or both of these exemptions apply for it only once to receive it in subsequent years. Application for these deductions can be made at the county assessors office where the property is located.

Quick overview of dates to remember:

January 1 - Property is assessed February 28 (29) - Application for Exemptions due

April 1 - Notice of Valuation mailed April 30 - Last day to challenge the assessment

November 1 - Tax bills are mailed. December 10 - 1st installment to tax payment delinquent after this date.

December 10 - January 9, 2010; Period during which you can file a complaint for a refund of property taxes that are challenged if you did not file a protest in 2009 — this is when complaints challenging tax lightning law must be filed.

Greater Albuquerque Area 3nd Quarter Home Sale Recap

The metro area housing market is still experiencing a continued adjustment in the average sales price and inventory. Comparison of 3rd quarter 2008 versus 2009 shows an average sales price still in decline at 8.57%. The inventory of homes in the market is now showing a significant decline as well, of almost 20%. This is a sign that our market may have hit the bottom. As inventory declines we should see a stabilization of the average sales price.

While sales for homes \$250,000 and below have been brisk, graphing sales numbers shows a significant lower number of buyers of higher priced homes. There were 62 sales in September in the \$300,000 price range versus only 16 sales in the \$400,000 price range. Signs of recovery have been slow for this higher priced market segment and some sellers are increasingly looking at short sales and foreclosure to help them.

Increase in sales over the last quarter could be a direct result of the first time home buyer tax credit ending soon. Should the tax credit be allowed to expire, we expect to see a slowdown in 4th quarter sales.

Overall the Albuquerque Metro market appears to be stabilizing and we are optimistic about the 2010 market. If you need detailed information on your home or investment contact your Premier GMAC Real Estate Professional.




Winter Emergency Car Kit

Chocolate Tres Leches Cake



1 can (14 oz.) sweetened condensed milk

1 can (12 oz.) evaporated milk

 $1/2\ cup\ BREAKSTONE'S\ or\ KNUDSEN\ Sour\ Cream$

1 cup thawed COOL WHIP Whipped Topping

PREPARE cake batter and bake in 13x9-inch pan as directed on package. Cool cake in pan 10 min. Pierce cake with large fork at 1/2-inch intervals.

MELT 3 chocolate squares; set aside. Blend milks and sour cream in blender until smooth. Add melted Chocolate; blend well. Slowly pour over cake, re-piercing cake as needed until milk mixture is absorbed. Refrigerate 1 hour.

MAKE curls or shavings from remaining chocolate square. Frost cake with COOL WHIP; top with chocolate curls. Refrigerate leftovers. *Makes about 16 servings*
